About the organisation: Multi Art Association (MAA) is a non-profit organization registered under Societies Registration Act – XXI of 1860. The organisation was established in the year of 2005. It was established to support and equip the grassroots groups on strategic thinking reflecting the grassroots issues. It has been supporting the groups working for protection of the rights of the tribal, dalits, women, children as part of the efforts to strengthen the society. For the last 13 years the organisation has been working among deprived and marginalized section of society The organisation is involved in creating awareness and capacity building among targeted groups in its area of operation.

Vision*: The organisation is inspired by the vision of sustainable development to build healthy, just and equitable society in which the tribal ,dalits, women, children and other marginalised and vulnerable section of society should have access to adequate health facility, quality education and to

ensure their right to work and right to food. Organisation also believe that tribal and dalit community should have adequate source of livelihood. This is to protect not only their fundamental rights and human values but also to protect environment, language, culture, tradition and to build ultimately a healthy, just and equitable society.

Mission*: Inspired by this vision, mission of organisation is to create awareness through education & organize workshops for the promotion of local cultural activities, to create legal awareness and ensuring the marginalized section of society their right over forest, water and land, to help and organize NREGA worker through NREGA help centre, to empower community for social & developmental entrepreneurship & livelihood training and support, to educate, inform and communicate through art, culture, study & research, to empower local community and SHG through education, traditional and agricultural activities.

Objective of organisation: Objective of organisation is

- to promote and help in the implementation of PESA, Panchayti Raj Act, for better self governance and strengthening grassroot democracy.
- to ensure the right to food, right to work and social security of poor and marginalized by monitoring the implementation of MNREGA, National Food Security Act,(which includes schemes like Public Distribution System, ICDS, Mid Day Meal and Maternal entitlement) social security pension schemes.
- to ensure the food and nutritional security of women, children and other vulnerable section
 of society through promotion of cultivation of traditional food grain like Madua etc and
 promotion of Poshan Garden. This will particularly helpful in addressing the problem of
 anemia among women of marginalized community.
- to bring transparency and accountability in governance through promotion and application of RTI and social audit
- to capacitate the human Resource for promotion, preservation, utilization and marketing of natural /local resource for ensuring food security and income generation of the poor and marginalized people.
- to promote, equality, peace, brotherhood and social justice by reducing Cast, Community, Religion, Sex and Region based conflicts and restoring the violated constitutional rights
- to sensitizes the society about gender equity and women empowerment
- Promotion of livelihood program through water and natural resource.
- to Save the water, land and forest.

Thematic Intervention Areas:

NREGA: The organisation has been working to ensure right to work of marginalised community of society through NREGA. Through CFT project of Rural development department it has tried to ensure smooth implementation and the monitoring of schemes in its area of operation in Manika and Barwadih block of Latehar. Besides the organization is also supporting the NREGA help centre in these blocks which act as link between the administration and the NREGA workers which help in addressing their grievance

Forest Right Act: The organisation is also working to ensure the forest right of tribal community through gram sabha in Latehar and Garhwa district.

Right to Food: The organisation has been working continuously to ensure right to food of poor and marginalised through monitoring of implementation and creating awareness about the provisions of National Food Security act in the operational area. The organisation has also helped in policy intervention by building public pressure and helping research and study in the operational area.

Self governance: The organisation believe that implementation of PESA in schedule area is one of the major instruments of community empowerment through strengthening gram sabha. The oragnisation has worked continuously to aware community about the provisions of PESA

Livelihood: Organisation is also working to strengthen the livelihood of community. In CFT-MNREGA project it is working on mango plantation project. Along with mango plantation its also working on intercropping. Organisation is also working to promote lac production and seed village.

Women empowerment and gender equity: The organisation is also working towards women empowerment and gender equity. With AALI (Association for advocacy and legal initiative) the organisation is working for addressing women's issue through right based perspective. The organisation tries to provide legal aid to women, especially those from marginalised and deprived communities, who are victim of domestic violence, trafficking, witch hunting etc. Organisation has also worked for promotion of gender equity and women empowerment in Daltangonj through Young Women Leadership Programme(YWLP) in association with FAT(Femisnist Approach to Technology). In this project young girls from marginalised community were given training in Information technology. They were trained in operating computer and other software skill. Besides the project also involved various workshops and field work which gave the young women opportunity to learn the value of gender equity and understanding and dealing with patriarchy.


